**One injured in Murshidabad bomb blast, class 12 student among 3 held**

A man was critically injured when a bomb he allegedly making exploded in West Bengal's Murshidabad district, a senior police officer said on Monday.

The injured was identified as Rihan Sheikh, he said. The explosion took place in Nazrana Baitragiasan village within Ramnagar police station limits on Sunday night.

Police on Monday morning arrested three persons, including a class 12 student, for their alleged involvement in making bombs, the officer said.

**Initial probe suggested the blast took place when the accused were making crude bombs, say police**

"Rihan sustained splinter wounds in his legs and is undergoing treatment at Murshidabad Medical College and Hospital," he said.

The three were to be produced at the Additional Chief Judicial Magistrate (ACJM) court in Lalbagh later on Monday, the officer said.

"An initial probe revealed that the injured and three others were making crude bombs when one of the explosives went off. We are investigating the matter," he added.

## Former CPI(M) leader Prasenjit Bose joins Congress, vows to 'oust both BJP & TMC'

PROSENJIT BOSE, a former CPI(M) leader once associated with the party's student wing SFI, joined the Congress in Kolkata on Monday, and vowed to fight both the BJP and the Trinamool Congress (TMC).

The event was attended by Congress leader Kanhaiya Kumar, party's state president Shauvankar Sarkar, Rajya Sabha MP Nasser Hussain, party observer Gulam Ahmed Meer and youth leader Imran Ali Ramji Victor among others.

Bose, who received the

Congress flag from Kanhaiya Kumar, said he and several close associates who worked with him during the NRC-CAA movement had also joined the party. Addressing the gathering, he said his aim was to strengthen the Congress both to oust the BJP from the Centre and to challenge the Trinamool Congress in West Bengal.

"Our target is twofold: to oust the BJP from the central government, which will be done under the leadership of Congress and party leader Rahul Gandhi, and to defeat those in Bengal who are helping Modi," Bose said.

Citing the Bihar SIR protest, where a large section of the

young electorate hit the streets against the unfair deletions of genuine voters, Bose said, "The way Rahul Gandhi has been able to mobilise the youth nationwide as seen during the Bihar SIR protest, a similar resistance needs to be built in Bengal."

Bose described Congress as the vehicle to break the polarisation between the TMC and the BJP in the state.

"Bengal people voted for TMC to defeat the BJP. Now they are realising that 'Didi' doesn't want to fight the BJP. We need a third alternative that can stand up to both the Trinamool and BJP," Kanhaiya Kumar said at the event.

An economist by training, Bose was formerly convener of the CPI(M)'s research unit. He was expelled from the party after questioning its decision to back UPA candidate Pranab Mukherjee in the 2012 presidential election.

In subsequent years he was not active in any party but took part in several movements, including protests against the NRC-CAA and campaigns opposing land acquisition at the Deocha Panchami coal project.

Bose has led and convened coalitions such as the Joint Forum against NRC in Kolkata and has advocated tribal rights in land-acquisition disputes.

have already been cancelled. "There have been complaints that some legitimate beneficiaries have been wrongly excluded. The chief minister has issued a warning to prevent such errors in the future," he said.

A decision was also reached during Monday's meeting that there would be greater emphasis on awareness campaigns to ensure SC beneficiaries have access to accurate information about government schemes and services, the bureaucrat said.

## Murder charges pressed in JU student's death case, say police

**Case filed after victim's father meets Kolkata Police Commissioner Verma**

CHARGES OF murder and criminal conspiracy were pressed on Monday in the case involving the death of a student due to alleged drowning at Jadavpur University after her parents met Kolkata Police Commissioner Manoj Verma and other officers.

Anamika Mondal, a third-year English literature student, was declared dead at a hospital after she was found unconscious in a pond near gate number 4 of the university on September 11 night.

Anamika's father Anab Mondal (49) filed a complaint at the Jadavpur police station on Monday afternoon, alleging she did not fall into the pond by accident. "Police should scan her mobile phone to find out who she spoke to that day," he said.

The case was registered under sections 103(1) (punishment for murder), 61(2) (criminal conspiracy), 3(5) (common intention) of the Bharatiya Nyaya Sanhita. Also, the investigation in the case has been taken up by the Homicide Squad of the Detective Department.

Deputy Commissioner of Police (DCP) Bidisha Kalita confirmed that a murder case was registered based on the father's complaint.

"As per the complainant, some unknown persons hatched a criminal conspiracy and committed murder of Anamika Mondal by pushing her into the pond at Jadavpur University. Investigation of the case is in progress," said police.

Police had initially registered a case of unnatural death taking suo motu cognisance of the incident. Police have taken the victim's mobile phone in their possession and summoned her friends for questioning as part of the ongoing investigation. The incident occurred during a drama club programme on the campus.

The initial post-mortem report had stated drowning as the cause of death.

Questions have been raised as how she could have fallen into the water, seemingly unnoticed, despite the presence of many people, CCTV cameras, and a security guard on the campus.

CCTV footage from the campus has been collected, and a forensic team has visited the spot. Samples have also been sent for viscera testing.

On Saturday, the National Commission for Women (NCW) took suo motu cognisance of the matter and sought a report from the university authorities and the Kolkata Police Commissioner within three days. NCW chairperson Vijaya Raghavkar wrote to the Police Commissioner, seeking a thorough investigation, forensic examination, and post-mortem report.

Archana Majumdar, an NCW member, had said, "The commission is anxious about what is happening in West Bengal. No child is safe there. Parents send their children for studies, and they come home dead. We will visit the university for inspection, we will also visit the deceased girl's family and the JU authorities," she said.

**Hospital facility manager held for 'sexually assaulting & raping' staffer**

A FACILITY manager at a hospital in Furba Medinipur was arrested after a female contractual worker accused him of sexual assault and rape.

According to police, the accused was apprehended in Kolaghat on Monday following a formal complaint from the victim.

Police said the victim, who worked as a contractual ward girl, alleged that the accused, who was her supervisor, repeatedly threatened her to keep silent about the abuse. She claimed that he used his position to coerce her, threatening that he would fire her or harm her, if she didn't comply with his demands.

"He repeatedly threatened me and took me to the room and sexually assaulted me," the victim said. She also claimed he "used to call me downstairs and do bad things."

Pellera sources said that an investigation into the matter was underway after the complaint was filed by the woman staffer.

The complainant said that many temporary workers are forced to endure such conditions out of fear of losing their jobs. "When that job goes away, we keep quiet about how we can make ends meet," she said. The allegations have once again brought the issue of staff safety in hospitals to the forefront, following a similar high-profile case at RG Kar Medical College in Kolkata.

A union leader spoke out about the need for security of health workers in hospitals. "The state government also needs to take active steps," the doctor said.

## State to take steps to resolve SC certificate issues

THE WEST BENGAL government is set to implement new measures to resolve complications surrounding the issuance of Scheduled Caste (SC) certificates, a senior official said on Monday.

The decision was taken at a meeting of the West Bengal Scheduled Castes Advisory Council, chaired by Chief Minister Mamata Banerjee at the state secretariat 'Nabanna' during the day.

According to a senior official

of the state secretariat, a major issue arises when persons applying for SC certificates are unable

to produce their parents' caste certificates.

"As per government rules, in

such cases, applicants must submit caste certificates of two blood relatives. However, in many instances, relatives are unwilling to cooperate. At today's meeting, there was a proposal to relax the norms and make it just one blood relative's certificate to complete the process. Chief Minister directed Chief Secretary Manoj Pant to take immediate steps in this regard," an official said.

The CM also directed Pant to take a firm stance against fake SC certificates. During the meeting, Backward Classes Welfare Minister Bulu Chik Baraik said that over 1,200 fake certificates

## Known for macabre comments, Abdur Rahim Boxi was shaped by the Left before rising in TMC

FROM THREATENING to cut off the hands and feet of his political rivals to threatening to pour acid into the mouth of Opposition leaders, Trinamool Congress (TMC) MLA Abdur Rahim Boxi is no stranger to stirring controversy with his macabre remarks.

The 62-year-old district unit president of the TMC's Malda unit was once a popular leader of the RSP, a Left Front constituent.

Raised in the Ratua area of Malda, a young sports Boxi was popular in his area for "lathi khela" (playing with sticks), kabaddi, and football.

He was associated with the Revolutionary Socialist Party (RSP) from his youth days. With the Left Front in power in West Bengal, he worked with the Integrated Child Development Scheme (ICDS) in the Malda district.

His first big political break came in the 2011 Assembly elections. Despite a wave against the Left Front, Boxi, then 47, was elected MLA from Maldaipur on an RSP ticket. In the same election, the Communists lost power to Mamata Banerjee-led TMC in the state for the first time in 34 years.

In the 2018 panchayat election, Boxi's wife, Ayesha Khatun, failed to win the Zila Parishad election from Ratua, and the TMC goes allegedly attacked their house.

But within six months of the incident, Boxi joined the TMC on January 11, 2019. BJP MLA Savendu Adhikari, who was then in the TMC, welcomed Boxi to the party.

Joining the TMC proved beneficial for him. His popularity within the ruling party soared, and in the 2021 Assembly elections, he was elected MLA from Maldaipur again as a TMC candidate.

Within one year, he was chosen as TMC's district president of Malda.

Just days before Boxi threatened to pour acid in the mouth of BJP chief whip Shankar Ghosh after the latter called migrant workers "Rohingyas" or "Bangladeshis", the Opposition party accused the TMC MLA of getting his job with MoS (Inigation) Sabina Tasmin.

"Sabina Yasmin used her influence and gave job to Abdur Rahim Boxi's daughter when lakhs of students are sitting on the streets of West Bengal demanding jobs," BJP MP and Union Minister Sukanta Majumdar had said recently.

Refuting the BJP's charge, Boxi had said his daughter was married and lived with her husband. "So, I don't know where she got the job," the TMC MLA had said.

Last week, while addressing people gathered to protest alleged atrocities against Bengali-speaking migrant workers in other Indian states, Boxi slammed BJP MLA Shankar Ghosh for his remarks in the Assembly in which he called Bengali-speaking migrants "Rohingyas and Bangladeshis".

"The one who shamelessly says that the 30 lakh migrant workers of Bengal who work outside are not Bengalis... they are Rohingyas, they are Bangladeshis. He shouted this. I said it then, and I am saying it today—if hear this from you again, I will burn your voice to ashes with acid inside your mouth. You should know that this is West Bengal. We Bengalis will not give you a place to speak. I will burn your face with acid," Boxi said as he urged supporters to "tear down BJP flags" and socially boycott the party in Malda. The BJP accused the TMC leader of promoting violence.

In Malda, Boxi is known for social work. He has established two higher secondary schools in Pukuria and Ratua. His son, Riyazul Karim Boxi, holds the position of secretary of the management committees in the two schools. Riyazul was also elected Zila Parishad member on a TMC ticket.
