3. **Period of Employment.**

- (a) Two years for ESM, second year extension based on satisfactory performance in first year.
- (b) Civilian candidates selected in lieu of ESM vacancy will be eligible to serve only till 11 months from the date of appointment.

4. In case the selected candidate fails to join duty, Stn Cdr will employ Reserve Candidate in "Panel of Res" as per order of merit. If 'Reserve Candidates' are exhausted, then will process for employ of reserves available from the Approved Lists of other Station Headquarters forwarded by this HQ.
