3. **Last date of receipt of application as per format given at our website.** Applications as per requisite format along with self attested photocopies of testimonials in support of Educational Qualifications and Work Experiences will be submitted to OIC, Stn HQs (ECHS Cell), Katihar by 28 Feb 2026 in duplicate. Any application received after 28 Feb 2026 will not be accepted.

4. **Interview Date, Timing & Venue.** Will be intimated telephonically/ SMS/ email. Candidates must bring all the original certificates/mark sheets/degree of 10 th / Matric, 10+2 & Graduation/post graduation/diploma/course, work experience and discharge book, PPO, service records and 02 (two) PP size colour photographs at the time of interview. No TA/DA is admissible. Only candidate meeting the Qualitative Requirement may apply. Also bring Medical fitness Certificate from SEMO/CMO at the time of interview.

5. **Overlapping of Handing/Taking Period & submission of Annual Property Return (Declaration of Assets).** 10 days of handing/taking over between the key appointments (Pharmacist, Nursing Assistant, Peon and Safaiwala) at Polyclinic will be carried out. The appt/extension letter will be issued only after submission of the said documents.
