4. **Interview Date Timing & Venue.** Candidate must reach ECHS Cell, Station HQ Gangtok at 0830 hrs on **27 Oct, 2026** for the interview to be held from 0900 hrs onwards. Candidates must bring all original certificates/ mark sheet/ degree of 10th, 10 + 2 & Graduation/post graduation/ diploma / course, work experience and discharge book, PPO, Service records and 01 PP size colour photographs at the time of interview.
