Now, get cooked food on Vande Bharat even without pre-booking

After the restriction on food services on trains imposed during the pandemic, were lifted, passengers who did not opt for food while booking their tickets could buy only ready-to-eat meals such as Maggi and chips.

On Friday, the Ministry of Railways wrote to the Chairman and Managing Director of IRCTC, saying, "For current booking and for non-opt passengers, the option of cooked meal may also be provided (available) which would be through the first provision, i.e. through the proposed state law and what was laid down by the UCC regulations. Justice Pankaj Mishra said that the Government was not aware that passengers would suffer from reluctance, should it not bring it to the notice of the State Government? How is the Government expected to know what is in the mind of the Government?"

The rule change applies only to Vande Bharat trains. Railway Ministry officials said there will be no change in the price of food and "non-opt" passengers will be charged the same as "opt" passengers.

"In 2021, when food services were resumed in trains after the COVID-19 pandemic, an option was provided that passengers can opt out for the meal and they will not have to pay food charges. For such passengers, Ready to Eat meals such as Maggi, Poha, chips etc. was available."
