
03. The email with the prescription should contain following information :-

- (a) Name of the beneficiary.
- (b) Name of the patient.
- (c) ECHS Smart Card Number of the patient.
- (d) Mobile telephone number of the patient or primary beneficiary.
- (e) Address at which the delivery is required.

04. Special sanction for reimbursement of expenditure for purchase of medicines has already been accorded till 30 Apr 2022 vide CO ECHS letter No B/49761/AG/ECHS dated 14 Jan 2022. Prescriptions generated through SeHAT OPD till 30 Apr 2022 will be valid instrument for purchase of medicines and claiming reimbursement.

05. You are requested to ensure wide dissemination of the above information to the beneficiaries and direct all the polyclinics to assist the beneficiaries in registration for SeHAT OPD as well as encourage home delivery of medicines.
